GENERAL RELEASE AND INDEMNITY AGREEMENT

I hereby represent that I am the parent or legal guardian of "PARTICIPANT" who is under the age of 18. For and in consideration of **Christy Moo Volleyball Camps** permitting PARTICIPANT to participate voluntarily in camp to be held on Charleston Southern University's campus in Charleston, South Carolina, hereinafter referred to as "CSU", I hereby expressly assume all the risks (e.g. inherent with Camp outdoor and indoor activities) associated with the Camp. I doing so, I release the head coach/owner of the Camp and CSU (its regents, officers, employees, students, and agents "RELEASED PARTIES") from all claims, demands, suits, causes of action, or judgments which I ever had, now have, or may have in the future or which our heirs, executors, administrators, or assigns may have, or claim to have against head coach/owner and CSU, its RELEASED PARTIES, arising out of or in any way connected with the Camp, for all personal injuries, known or unknown, property damages, or claims for wrongful death, caused by the ACTS, OMISSIONS OR NEGLIGENCE of head coach, owner and CSU, its RELEASED PARTIES. I understand this waiver does not apply to injuries caused by head coach/owner's or CSU's intentional or grossly negligent conduct.

I further agree to indemnify and hold harmless RELEASED PARTIES from all claims, demands, suits, causes of action, or judgments which participant of I ever had, now have, or may have in the future or which our heirs, executors, administrators, or assigns may have, or claim to have against RELEASED PARTIES, arising out of or in any way connected with the Camp, for all personal injuries, known, or unknown, property damages (including lost or stolen property), or claims for wrongful death, caused by the acts, omissions or negligence of RELEASED PARTIES, and on head coach/owner's behalf and in head coach/owner's name defend at my own expense any such claims, demands, suits, causes of action or judgments described above. I also agree to be responsible for any property damage or personal injuries that participant or I may cause by intentional or negligent acts while participating in the Camp.

PHOTO RELEASE

I hereby grant to the head coach/owner the right to reproduce, use, exhibit, display, broadcast, distribute and create derivative works of camp related photographs or videotaped images of PARTICIPANT for use in connection with the activities of the Camp or for promotion or publication of its camp activities. These images may appear in any of the wide variety of formats and media now available to the head coach/owner and that may be available in the future, including but not limited to print, broadcast, videotape, CD-ROM and electronic/online media. All photos taken are without compensation to PARTICIPANT. All electronic or non-electronic negatives, positives, and prints are owned by the head coach/owner.
